NPHA Outcomes 2020

30 families moved into permanent housing

5 women opened banking accounts at New Phoebe House
6 have banking accounts while in Aftercare

4 gained employment at NPHA
11 were employed in Aftercare

12 mothers gained custody while living at NPHA
15 had custody upon entering at NPHA

16 mothers increased their custody status while at NPHA
19 mothers have custody in Aftercare

33 children received trauma-reducing programming through the Phoebe Kids Play program

31 mothers received counseling while at NPHA
10 mothers received counseling while in Aftercare

45 mothers and 33 children lived at NPHA
21 mothers and 27 children were served in Aftercare

Goals Achieved in 2020

Revised acceptance criteria to include clients on Medication Assisted Treatment (MAT).

Maintained and added to full array of services despite COVID-19 pandemic, including facilitating virtual visits for mothers and children at NPHA.

Converted three administrative spaces into bedrooms to increase occupancy at New Phoebe House.

Increased diversity on NPHA Board per our strategic initiative goal with three new board members, including two individuals of color.

Increased the daily safety and security of clients with grant to install new security system.

Increased staffing and technological resources to support children attending virtual schooling and families working with outside support services.

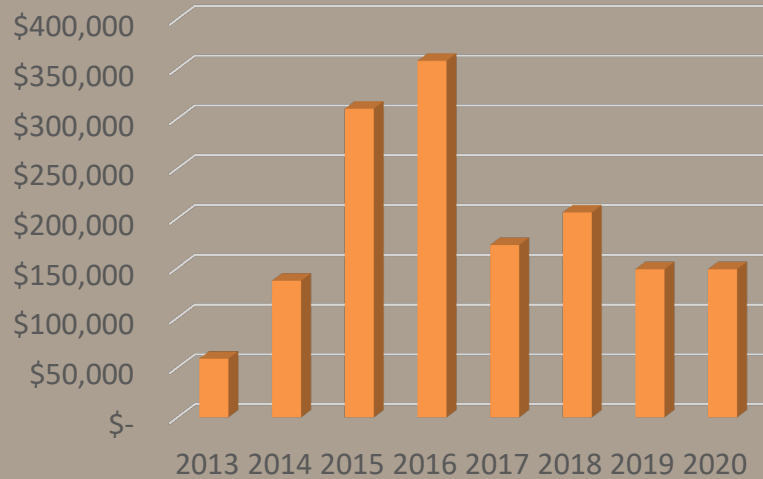

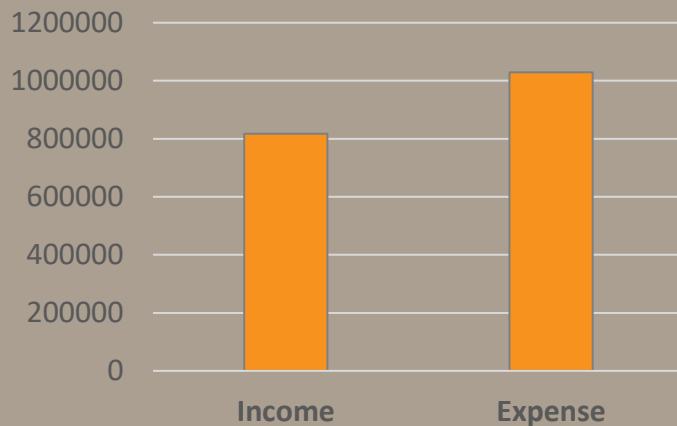
2020 Government Contributors City of Tacoma Pierce County
